## KEY DEADLINES

### REGISTRATION OF COMPANY

- All Person-In-Charge (PIC) must register their company by **Monday, 28 October**.
- The last date to opt in for delivery service is **Monday, 2 September** – Only applicable to companies that purchased 50 entries and above.
- Please note that the individual links will only be released after payment has been received.

### INDIVIDUAL REGISTRATION

- Companies with Delivery Opt-In: Please register by **Friday, 27 September**. After this date, you will still be able to register till **Friday, 22 November**.

However, you will have to head down to Sands Expo & Convention Centre Hall F to collect your race pack in person.

- All Others: Please register by **Friday, 22 November**.
